**No site visit or interview required**

### ***Important Notes:***

- Entry into this category does **not** require accreditation or certification in order to be eligible.
- The award will not be made to the same person twice.
- Nominations are acceptable from any party except the nominee.
- The word limit for this submission is 2500 words (not including CV, letters of recommendation, etc).
- The nominee's Curriculum Vitae and no more than 3 letters of recommendation may be included.
- Copy of documentation such as driver's licence, passport etc should be included to verify age.
- This award will be presented at the discretion of the judges, based on the submissions received.
- The provision of this category is specific to the Queensland Tourism Awards and the winner will not go on to become a finalist in the Australian Tourism Awards.

**The judges will take into account the following aspects of the contribution when assessing a nomination.**

Activities resulting in the improvement of industry standards, participation in industry organisations and representation are other good examples. The emphasis should be on personal and professional commitment.*
